

# Home-Schooled In-Car Driver Education PARENTAL AUTHORIZATION APPLICATION

**Purpose:** Use this form to apply for authorization to conduct in-car driver education for your child. Pursuant to § 22.1-205 of the Code of Virginia, the parent/legal guardian of a home-schooled minor may provide in-car instruction to the child, provided the child meets the requirements for home school instruction under §§ 22.1-254(B) or 22.1-254.1 of the Code of Virginia.

**Instructions:**

1. Complete this form in ink or type;
2. Attach a copy of either:
  - The notification to the school division superintendent/designee of your intent to home-school the child (the name of the school division and/or the superintendent/designee must appear on the notification),  
OR
  - A letter from the school division superintendent/designee acknowledging that the child is home-schooled;
3. Attach the original proof of completion of the classroom portion of the driver education program;
4. Mail this form and attachments to the Commercial Licensing Work Center at the address above.
