- Taught Elementary Music in LCPS (Full Time at LUC; Itinerant at HIL, FHR, LEE, LOV, PMK, LIB, LRE, & MTV) from 2003-2012. Also taught After School Orchestra at ASH.
- Served as member of LCPS Elementary Music Textbook Adoption Committee.
- Alto Section Leader, Mezzo-Soprano Soloist, & Youth Choir Director of Redeemer Lutheran Church McLean 2005-present.
- Volunteer at Lucketts Community Food Pantry (Loudoun Hunger Relief) from 2016-present.

- Worked with members of the Loudoun County School Board and Board of Supervisors to secure a 3-classroom expansion for Lucketts Elementary School. Further advocated to have the expansion funded by EOY funds from the county.

It would be my honor to serve as the representative for the Catoctin district on the Loudoun County School Board. I believe my skills and experience put me in a position to work seamlessly with current School Board members to ensure all of the students in LCPS receive the highest quality education. As the only candidate with a current teaching license and prior experience teaching in LCPS, I have a pulse on the needs and

concerns of LCPS Teachers and Staff and will be a strong advocate for our employees and students. I am solutions-oriented and do not bring problems to the table without a couple of proposed solutions to discuss. I have an amicable rapport with Board of Supervisors members and would continue to build these relationships should I be elected, and I would be honored to serve on the joint SB/BOS Committee. I am innately driven and a problem solver, and look forward to using my skill set to work with my fellow School Board members to bring student-centered solutions to LCPS.
