





#### TOWN OF LEESBURG TOWN COUNCIL WORK SESSION

**Subject:** Douglass High School Art Mural

<u>Council Action Requested:</u> Approve a mural submitted by Jason Tetlak for installation on the exterior wall of the gymnasium at the historic Douglass High School, located at 407 East Market Street. See attachments #2 and #3.

**Staff Recommendation:** Approval of a mural on the exterior wall of the gymnasium at the historic Douglass High School, located at 407 East Market Street. This project is proposed pursuant to the Town of Leesburg Private Property Mural Program where the County is licensing the wall to the Town.

In conformance with the Private Property Mural Program, the Town Attorney has approved the project. See Attachment #4. A lease agreement between the Town and the owner of the property (Loudoun County Public Schools) is required for the wall surface, and an agreement with the artist will also be needed.

<u>Commission Recommendation:</u> The Commission on Public Art supports and recommends approval of a mural submitted by Jason Tetlak for installation on the exterior wall of the gymnasium at the historic Douglass High School, located at 407 East Market Street.

**Fiscal Impact:** No public funding from the Town is needed. The entire project will be funded by Loudoun County Public Schools. The cost of this project is unknown at this time.

Work Plan Impact: None.

<u>Town Plan Impact</u>: The Legacy Leesburg Town Plan makes multiple references to the creation of public art: Section 1.3.1 Seek Out Opportunities to Expand Public Art states that "the Legacy Leesburg planning process identified the community's strong appreciation for public art. The Town will continue to develop, refine, and follow its Public Art Vision and work with appropriate entities to introduce new art. Consideration will also be given to interactive and digital public art across the Town's public realm to tell the stories of Leesburg's diverse communities, promote informal interaction, and provide the Town's arts community with an active voice for bring."

Section 1.1.1c Identify and Pursue Town Led Preservation and Strengthening Efforts states "Given the range of opportunities, the Town should consider developing an Old and Historic District Preservation and Enhancement Plan...This Plan could include topics such as: approaches and programs to address maintenance and encourage rehabilitation; support of a non-profit, third-party preservation organization; identifying appropriate locations and/or highlighting historic content for public art in the Historic District."

Finally, Strategy 3.3.3 Create Public Places That Promote a Sense of Community for an Increasingly Diverse Population: Tell everyone's stories. It is critical to program spaces with public art that tells the diverse stories of people who live in a neighborhood, so everyone feels public space is about them.

Executive Summary: Loudoun County Public Schools (LCPS) in coordination with the Douglass High School Commemorative Committee (DHSCC) issued a Call for Artists in September 2022 for a mural at the historic Douglass High School. The DHSCC selected Jason Tetlak's artwork at their December 12, 2022 Committee Meeting showing African Americans participating in sports that were played at Douglass High School. See Attachment #2.

Pursuant to the Private Property Mural Program established per Resolution No. 2022-030, the proposed mural must be approved by Town Council prior to installation. See Attachment #4.

**Background:** Town Council approved the Private Property Mural Program in March 2022 per Resolution No. 2022-030. See Attachment #4.

These guidelines are for murals placed on private property, facilities, or grounds, which are not the property of the Town of Leesburg. This program excludes the H-1 District. These guidelines help ensure that the location, size, shape, color palette, materials used, and relationship to historic context meet the goals of this program, while striking an appropriate balance between historic character and artistic expression.

WHEREAS, the Town Council is committed to supporting performing and visual arts activities within the Town of Leesburg; and

WHEREAS, at its July 13, 2021 meeting, Council approved the creation of a Private Property Mural Pilot Program Committee per Resolution No. 2021- 101 to consider development of a program allowing murals on commercial properties located outside of the H1 District, which are currently not permitted under the Town's Zoning Ordinance; and

WHEREAS, Loudoun County Public Schools has expressed interest in a mural that would be displayed on the outside wall of the gym, which is adjacent to an outdoor basketball court; and

WHEREAS, Loudoun County Public Schools submitted a "Call to Artists" prior to selecting artwork submitted by Jason Tetlak, which depicts football, boys and girls basketball, baseball, golf, track, and cheerleading; and

WHEREAS, Loudoun County Public Schools has agreed to fund this project in full; and WHEREAS, the Commission on Public endorsed this project following a presentation made by Donna Torraca, staff liaison to the Douglass High School Commemorative Committee, on February 6, 2023; and

WHEREAS, this project being proposed is pursuant to the private property mural program where the County is licensing the wall to the Town; and

A RESOLUTION: APPROVAL OF DOUGLASS HIGH SCHOOL ART MURAL DESIGNED BY ARTIST JASON TETLAK

WHEREAS, the Town Attorney has approved the project as long as the wall surface is the subject of a lease agreement between the Town and the owner of the property as well as an acceptable agreement with the artist; and

WHEREAS, the Leesburg Town Council must endorse all art displayed on public and private property.

THEREFORE, RESOLVED, by the Council of the Town of Leesburg that the Douglass High School mural project by Jason Tetlak, under the Private Property Mural Pilot Program, is endorsed for installation at Douglass High School.

ADOPTION OF A LIMITED PRIVATE PROPERTY MURAL PILOT PROGRAM AND INITIATION OF AMENDMENTS TO ARTICLE 18 OF THE ZONING ORDINANCE TO REDEFINE

THE TERM MURAL

WHEREAS, the Town Council is committed to supporting performing and visual arts activities within the Town of Leesburg; and

WHEREAS, at its July 13, 2021 meeting, Council approved the creation of a Private Property Mural Pilot Program Committee per Resolution No. 2021-101 to consider development of a program allowing murals on commercial properties located outside of the H-1 District, which are currently not permitted under the Town's Zoning Ordinance; and

WHEREAS, the Economic Development Commission, the Commission on Public Art, and the Board of Architectural Review each designated a member to serve on the Committee, chaired by Councilman Ara Bagdasarian, and the Committee was supported by necessary Town staff; and

WHEREAS, the committee spent extensive time discussing the purpose, goals, format, and legalities of a pilot program, including current land use regulations and policies, zoning ordinances, and public art guidelines; and

WHEREAS, on January 7, 2022 the committee adopted recommended guidelines to establish a pilot program for Council consideration; and

WHEREAS, any eligible property's participation in the pilot program shall be on a voluntary basis; and will be subject to a written agreement, developed by staff and the Committee.

THEREFORE, RESOLVED, by the Council of the Town of Leesburg in Virginia as follows:

A RESOLUTION: ADOPTION OF A LIMITED PRIVATE PROPERTY MURAL PILOT PROGRAM AND INITIATION OF AMENDMENTS TO ARTICLE 18 OF THE ZONING ORDINANCE TO REDEFINE THE TERM MURAL

1. Town Council hereby adopts a limited pilot program for murals on private commercial property excluding the H-1 Overlay District, subject to the attached Private Property Mural Guidelines (the "Guidelines"), and subject to an approved amendment in the Zoning Ordinance redefining the term "Mural".

2. Amendments to the Zoning Ordinance are hereby initiated and recommended to the Planning Commission to amend Article 18 to redefine the term "Mural".

3. The Planning Commission shall hold a public hearing to consider amendments to the Zoning Ordinance redefining the term "Mural", and report its recommendation to the Town Council pursuant the Section 15.2-2204 of the 1950 Code of Virginia, as amended

4. Once Town Council approves an amendment to the Zoning Ordinance that redefines the term "Mural", the Private Property Mural Committee shall manage the initial installation, including the theme, wall location, and artwork, until otherwise dismissed by Council.

5. The Private Property Mural Guidelines shall be re-evaluated by Town Council one year after official enactment.

#### **Mural Proposal**

My proposal for this mural is called *Game Time*, and it focuses on the idea of people coming together to enjoy themselves in friendly competition. Figures and icons representing various sports including baseball, basketball, cheer leading, golf, track and football break the surface up into smaller shapes that are filled with bright, eye-catching colors. Special attention was given to ensure windows and other features of the wall do not obstruct any of the design elements.





As requested here is a color option for the golf ball. My opinion is to leave it white as origonally proposed, but I am ok with either of these options as well.

#### **Mural Proposal - Continued**

My proposal for this project utilizes a 12 foot section at the top of the wall, allowing for the mural to be 8 feet up off the ground in order to minimize the potential for damage and vandalism. My design also fits between the existing raised dividers on the wall.





#### **Initial Proposal from the Reconciliation Subcommittee**

The Reconciliation Subcommittee recommends that the Joint Committee endorse the creation of a professionally produced and distributed documentary telling the story of Douglass High School. The focus would be on bringing a face and a story to Douglass High School, its students, and its teachers. The documentary would give alumni a chance to tell their stories and keep those stories from getting lost.

#### Existing resources:

- LCPS has been recording interviews for museum kiosks, as well as the committee for a minidocumentary to run on LCPS TV.
- Joan Sahlgren of LCPS has previously worked on a documentary for a national marketing campaign and was able to provide advice to the subcommittee.
- Visit Loudoun, Economic Development are potential partners.
- Local media connections?

#### Considerations/ Resources needed:

- Will need a partner like an agency that will cast a director and production company.
  - o Determine perspective or angle to tell story from.
  - Help develop considerations for timeline and budget.
- Committee to guide how to order the pieces of the story and tell it; map out a script along with the timeline photos and existing interviews.
  - Decide who to interview, and where.

#### Timeline:

- Completion in 6 months to a year from funding date
- Several months to shoot, then edit and check facts.
- More flexibility if there is no firm deadline for completion.

#### Funding:

- Estimates will need to be obtained to develop the request to the Board of Supervisors.
- Corporate or underwriting partners could help fund the project.
- Consider paid ads to drive traffic to streaming sites (such as Hulu / Vubu/ YouTube) which host the content.

#### Benefits:

Film could have other uses: pieces to use by Visit Loudoun, commercials, DHS museum, etc.

#### Reconciliation Committee Decision points:

- What is the scope of the project? What years? The story itself extends from 1935 to 1968.
- How long would the film be?
- Who 'owns' the project? Who provides guidance and will see it through to the completion?
   Options include:
  - o DHS Consortium
  - o Reconciliation committee
  - o Newly formed committee to be selected by Reconciliation Committee
- Who else should be part of this discussion?
