The Capital Renewal and Alteration (CRA) is a separately funded project and is an aggregate of multiple projects across all school and ancillary campuses within LCPS. Due to the flexible nature of the CRA, LCPS planned and moved projects to accommodate the available funding for FY25 and provided a full needs based project list for FY26 and beyond. What is causing the delay in building HS-14? It is fully funded in FY25, but not due to open until the 2029-30 school year. How can the high school be accelerated by one year and open 2027

HS 14 is planned and on schedule to open for the 2028-2029 school year, not the 2029-2030 school year. It is not possible to accelerate and open the school in the fall of 2027. There are a number of factors including but not limited to a significant amount of earthwork and rock removal and the requirement for improvements to Evergreen Mills Road to be complete prior to the opening of the school.

Is the expansion of Evergreen Mills Road at Ryan Road included as part of the construction costs of HS-14? What portion of the transportation infrastructure will be complete with the opening of Watson Mountain Middle School?

The expansion of Evergreen Mills Road from Ryan Rd to connect with current 4 lane improvements just north of Creighton Rd are part of the scope of work for the project and are required to be in service prior to the opening of HS 14.
