# Department of Pupil Services and the Office of Special Education Office of Special Education, Dr. Patricia Nelson

- Policy 8155 should be removed from the School Board agenda for further review and recommendations. LCPS will be joining a cohort with 20 other schools transitioning to Virginia IEP for IEP information. LCPS will include the Parent Portal. Training has begun for staff and will be offered to parents. COVID Recovery Services and ESY as determined by IEP teams. All services are being provided at the same building so students can access both COVID Recovery and ESY at the same location as determined by the IEP team.
- John Lody, Director of Diagnostic and Prevention Services made himself available to answer concerns presented on IEEs.

# Department of Pupil Services, Dr. Asia Jones

- Summer programming being offered in person and virtually. Actively recruiting for the summer programs. Still asking for families to exercise community care. People at the age of 15 are being offered the COVID vaccine and communications have been shared at the high school level. Looking forward to increasing in person activities including sports, concerts, and in person graduations.

## **IEE Concerns**

- Current cost containment guidelines are lower than market rates for evaluations. LCPS cost containment guidelines are lower than Fairfax and Prince William County's current cost containment guidelines. LCPS list of approved providers is lacking. Need a sufficient and comprehensive plan to meet all obligations and needs to provide IEEs at no cost to the parents.
- John Lody shared all requests have been handled in a timely manner since moving to his office to ensure it is in compliance. In process of gathering a list of additional providers.

# Policy 8080, Home Instruction/Home Schooling

- Concern 1: Draft Policy 8080, Home Instruction (Home Schooling) does not address LCPS's regulatory obligations under the Individuals with Disabilities Education Improvement Act (IDEA) and in the Virginia Regulations Governing Special Education Programs for Children with Disabilities in Virginia.
- Recommendation 1: Add New Section B. B. LCPS Obligations. Upon LCPS receiving of the Notice of Intent for home instruction, LCPS shall inform the parent/guardian of the following rights under the Virginia Individuals with Disabilities Education Improvement Act (IDEA) Regulations, 2. Consultation on Child 3. Services Plan 4. Proportionate Set Aside funds 5. Consultation on the design and development of special education and related services for home instructed students Home schooled students are considered to be "private school" students as defined in 8 VAC 20-81-150(C)(1)(a).

Nothing in the draft policy considers LCPS' IDEA obligations
