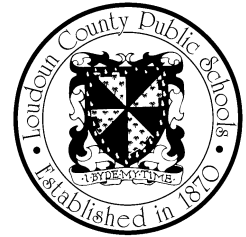

#### **Loudoun County Public Schools' Insurance Does Not Provide Coverage for Students' and Employees' Personal Property Brought to School.**

Each year the LCPS Procurement/Risk Management Division receives claims where school students and employees have lost valuable personal property brought to school. Every type of personal property is subject to loss by accident, theft, or vandalism.

Examples of property include:

**Technology/Digital Equipment/Devices, Smart Phones, Assistive Devices, Musical Instruments, Watches, Jewelry, Glasses, Jackets, Clothes, Shoes, Purses, Backpacks, Sporting Goods, Bicycles, Vehicles, etc.**

Loudoun County School Board/Loudoun County Public Schools does not accept responsibility for the damage to or loss of student or employee owned property brought to school.

For the loss/damage to technology devices, the **Worth Avenue Group** has been providing technology device insurance programs to thousands of students and staff across the country since 1971. Their insurance plans have been utilized nationwide by many colleges, universities, and K-12 school students, faculty, and staff.

**Losses Covered:** The plans cover loss or damage, occurring during the policy period, to personal technology devices, which you own or have leased. See policy for items excluded from coverage.
